## What Is Whiplash and How Does It Happen?

Whiplash is a soft tissue injury that typically affects the neck and upper back. It occurs when the head is suddenly jerked forward and backward—a motion most common in [rear-end collisions](#). The force stretches and tears muscles, tendons, and ligaments in the neck, often resulting in pain and limited mobility.

Common symptoms of whiplash include:

- Neck pain or stiffness
- Headaches, especially at the base of the skull
- Shoulder or upper back pain
- Dizziness or fatigue
- Numbness or tingling in the arms
- Difficulty concentrating or memory issues

Some symptoms may appear right away, but others can take days to develop. That's why it's critical to seek medical attention immediately after any crash, even if you feel fine at first.
