Crosswalks Don't Always Keep Pedestrians Safe

Crosswalks exist to protect pedestrians, but that doesn't mean drivers always obey the law. In Georgia, drivers are legally required to stop for pedestrians in marked crosswalks and yield the right-of-way when appropriate. Unfortunately, distracted driving, speeding, and aggressive behavior often result in devastating crashes.

Crosswalk accidents are common at:

- Intersections with poor signal timing
- Unmarked or faded crosswalks in urban areas
- School zones and residential streets.
- Multi-lane roads with heavy traffic

Even with clear pedestrian signals, drivers may claim they "didn't see" the person walking or try to blame the victim. That's why it's important to act quickly after a crash to protect your legal interests.

What to Do Immediately After a Crosswalk Crash

The moments after being hit are overwhelming—but what you do next can make a difference in your recovery and your case.

Steps to take include:

- Seek immediate medical attention, even if injuries seem minor at first.
- Call 911 so the police can document the crash.
- Get witness information, if possible.
- Take photos of the scene, vehicle, injuries, and the crosswalk itself.
- Avoid making statements about fault to the driver or insurer.
- Speak to a lawyer before talking to the insurance company.

These steps help preserve crucial evidence, establish liability, and strengthen your future claim for compensation.

Why Fault in Crosswalk Crashes Isn't Always Clear-Cut

Pedestrians often assume they'll automatically be protected under the law—but insurance companies don't treat these cases that way. In Georgia, the insurance company may try to argue that the pedestrian wasn't paying attention, crossed outside the signal, or acted negligently.

Injuries in Crosswalk Collisions Are Often Life-Changing

Crosswalk accidents typically involve a direct impact to the pedestrian's body, often resulting in catastrophic injuries. Unlike car occupants, pedestrians have no protection from the force of a moving vehicle.

Common injuries include:

- Broken bones and fractures
- Traumatic brain injuries
- Spinal cord injuries
- Internal bleeding or organ damage
- Road rash and facial trauma
- Long-term disability or chronic pain

These injuries may require surgery, rehabilitation, in-home care, or permanent medical support. Many victims are left unable to work or enjoy their previous quality of life.

When Children Are Hit in Crosswalks

Crosswalk Hit-and-Runs Require Aggressive Legal Action

If you were the victim of a hit-and-run:

- Call 911 immediately and request police assistance.
- Provide any details about the fleeing vehicle, including make, color, or partial plate.
- Look for surveillance cameras from nearby homes or businesses.
- Contact an attorney quickly to begin an investigation.

Even if the driver is never located, you may still have legal options. Our attorneys pursue claims through your own uninsured motorist (UM) coverage, if available, or explore other sources of liability—such as a bar that overserved the driver or an employer if the vehicle was work-related.
