## What Makes Road Rash So Serious?

Road rash isn’t just a small scrape or cut. Depending on the force and speed of the fall, it can involve:

- Deep abrasions and lacerations that require stitches and surgical cleanup
- Embedded gravel or debris, which increases infection risk
- Full-thickness skin loss, leading to significant scarring or grafting
- Emotional trauma, pain, and anxiety tied to severe visible injuries
