Passenger Injuries in Georgia Motorcycle Crashes Are Often Severe

Passengers are just as vulnerable as motorcycle operators—sometimes even more so. In many cases, they're thrown from the bike during a crash and may not have the same level of situational awareness or grip strength as the rider. Common passenger injuries include:

- <u>Traumatic brain injuries (TBIs)</u>, even with a helmet
- Spinal cord injuries and paralysis
- Broken legs, arms, ribs, or pelvis
- Road rash, burns, and deep lacerations
- Internal injuries or organ damage
- Emotional trauma and PTSD

These are not minor injuries. Motorcycle passengers often face long-term hospital stays, rehabilitation, and lost income. Some never fully recover.

That's why seeking immediate medical treatment and strong legal representation is critical.

Who Is Legally Responsible When a Motorcycle Passenger Is Injured?

Georgia law allows injured passengers to pursue a personal injury claim against any party whose negligence contributed to the crash. Depending on the circumstances, that may include:

The Motorcycle Driver

If the driver of the motorcycle was speeding, weaving through traffic, or otherwise riding recklessly, they may be liable—even if they're a friend or loved one. This is often a difficult conversation, but your claim is typically handled through their insurance policy, not their personal assets.

Another Driver

If another vehicle caused the crash—by turning left in front of the motorcycle, following too closely, or failing to yield—that driver's insurance could be responsible for your injuries.

A Third Party

In some cases, poor road design, mechanical defects, or even negligent maintenance could contribute to a motorcycle crash. When that happens, a city, manufacturer, or maintenance provider might also be at fault.

Georgia follows a modified comparative negligence rule. That means you can recover damages as long as you're less than 50% at fault. As a passenger, your percentage of fault is generally zero unless you did something that directly contributed to the crash (like distracting the driver or interfering with the controls).

What Kind of Compensation Can Motorcycle Passengers Receive?

Injured passengers may be eligible for compensation that covers both economic and non-economic damages, including:

- Medical bills (hospital stays, surgeries, medications, rehab)
- Future medical costs and long-term care
- Lost wages and lost earning potential
- Pain and suffering
- Emotional distress
- Loss of enjoyment of life

In rare cases, if gross negligence was involved—such as drunk driving or extreme recklessness—punitive damages may also be pursued.

How Does Motorcycle Insurance Work for Passenger Injuries?

Georgia law requires motorcycles to carry minimum liability coverage, which may help cover a passenger's injuries. However, the minimum limits (\$25,000 per person, \$50,000 per accident) are often far too low to cover serious injuries.

That's why it's important to investigate all potential sources of insurance coverage, including:

- The motorcycle operator's liability coverage
- The at-fault driver's liability coverage (if a car caused the crash)
- Uninsured/underinsured motorist (UM/UIM) coverage on either policy
- MedPay (medical payments coverage), if available

Some injuries—especially internal injuries or brain trauma—aren't obvious right away. Always see a doctor after a crash.

Document Everything

Keep track of your medical records, prescriptions, doctor notes, and any out-of-pocket expenses. If you have photos of the scene or contact info for witnesses, save those as well.

Avoid Giving Recorded Statements

Insurance adjusters may try to get you on record, downplaying your injuries or blaming the motorcycle operator. Politely decline until you speak with a lawyer.
