# What to Do If a UPS Truck Hits Your Car in Georgia

## **Why UPS Truck Accidents Are So Serious**

Before diving into the steps to take after a collision, it helps to understand why accidents involving UPS trucks often become complicated. UPS operates one of the largest delivery fleets in the world. Their trucks are heavier and more challenging to maneuver than standard passenger vehicles. When a fully loaded delivery truck collides with a smaller car, the resulting damage and injuries can be severe.

Additionally, UPS is a huge corporation with dedicated insurance adjusters and legal teams who are trained to minimize payouts. They may quickly look for reasons to reduce or deny your claim. This makes it critical to treat your case with the seriousness it deserves right from the start.

### Immediate Steps to Take at the Crash Scene

#### 1. Call 911 and Get Medical Help

After any collision, safety comes first. If anyone is hurt, call 911 immediately and request an ambulance. Even if you feel okay, you should still get checked by paramedics or visit an emergency room soon after the crash. Many serious injuries, including traumatic brain injuries or internal bleeding, are not obvious right away.

#### 2. Notify Law Enforcement

Always wait for the police to arrive and make an <u>official accident report</u>. This report will be a key piece of evidence in your UPS truck accident claim. Be honest and cooperative, but avoid admitting fault or speculating about what caused the crash. Stick to the facts.

#### 3. Document The Scene

If it is safe to do so, take pictures and videos of everything: vehicle damage, the UPS truck's license plate and USDOT number, debris on the road, skid marks, and traffic signals or signs nearby. Also get photos of your injuries. If there are witnesses, try to collect their contact information. This evidence may become crucial if the trucking company later disputes what happened.

#### 4. Exchange Information

Get the UPS driver's name, employee ID (if available), and insurance details. Commercial trucks often have multiple parties involved, such as the driver, the company, and possibly maintenance contractors. Collect as much information as possible at the scene.

#### 5. Seek Medical Attention And Follow Up On All Care

Even if you left the scene in an ambulance, you still need to keep up with follow-up appointments, therapy, and specialist visits. Your health is the top priority. Additionally, medical records that clearly link your injuries to the accident are essential to proving your claim. <a href="Insurance companies">Insurance companies</a> often look for gaps in treatment to argue that you were not seriously hurt.

If you start to feel new pain in the days after the accident, do not ignore it. Many injury symptoms appear gradually. Always report new or worsening issues to your doctor.

#### 6. Notify Your Insurance Company...But Be Cautious

You will need to report the accident to your own auto insurer. Stick to the basic facts and avoid going into unnecessary detail. You do not need to give a recorded statement without first talking to a lawyer. If the UPS insurance adjuster contacts you, politely decline to discuss the incident until you have legal representation. Large companies often train adjusters to look for ways to shift blame or minimize payouts.

### How a UPS Truck Accident Claim Works in Georgia

UPS drivers are held to higher safety standards because they operate large commercial vehicles.
