## **Why Distracted Driving Is So Dangerous For Motorcyclists**

A passenger car driver might escape with only minor injuries in a distracted driving crash. For motorcyclists, the same collision often results in catastrophic harm. With no protective frame, airbags, or seatbelts, riders absorb the full force of impact.

Common factors that make these crashes especially dangerous include:

- **Reduced Visibility:** Drivers who are looking at a phone or other distraction are less likely to notice a motorcycle in their blind spot or approaching an intersection.
- **Shorter Reaction Times:** A driver glancing down at a text loses critical seconds to brake or swerve.
- **Higher Impact Severity:** Distracted drivers often fail to slow down before impact, increasing the risk of severe or fatal injuries.

According to the [National Highway Traffic Safety Administration \(NHTSA\)](#), distracted driving kills thousands of people every year, and motorcyclists remain one of the most at-risk groups.

## **Common Types Of Distractions That Lead To Motorcycle Crashes**

Distraction takes many forms, but certain behaviors are especially dangerous when motorcycles share the road.

### **Cell Phone Use**

Texting, scrolling social media, or even using navigation apps while driving creates a “triple distraction” — visual, manual, and cognitive. For motorcyclists, even a brief glance away from the road can mean a driver never sees them before impact.

## **Eating Or Drinking**

Drivers eating behind the wheel take at least one hand off the steering wheel and often divert their eyes from traffic. This loss of control can be deadly when a motorcyclist is nearby.

## **Adjusting Controls Or Entertainment Systems**

Changing a playlist, adjusting climate controls, or fiddling with GPS systems may only take seconds, but those seconds can be the difference between a safe pass and a [rear-end collision](#).

## **Talking To Passengers**

Conversations, especially heated or emotional ones, can shift a driver's focus away from the road. This cognitive distraction reduces their ability to respond quickly to changing traffic patterns.

## **Drowsy Or Fatigued Driving**

Fatigue can act as a form of distraction, slowing reaction times and reducing awareness of surrounding vehicles, including motorcycles.

## **How Distracted Driving Crashes Impact Georgia Riders**
