#### The Scope of the Drunk Driving Crisis in Georgia

According to the <u>Georgia Governor's Office of Highway Safety</u>, more than 400 people lose their lives each year in alcohol-impaired crashes. Nationwide, the <u>National Highway Traffic Safety</u> <u>Administration (NHTSA)</u> reports that nearly one-third of all traffic deaths involve a driver under the influence.

Behind every number is a story: a parent driving home from work, a teen on their way to practice, a couple coming back from dinner. These aren't just statistics. They're reminders that one reckless decision can change dozens of lives in seconds.

Despite stricter laws, awareness campaigns, and tougher penalties, <u>drunk driving</u> continues to plague Georgia's highways. The truth is, enforcement and education can only do so much. Real change and accountability often starts in the courtroom.

## **Understanding Wrongful Death Under Georgia Law**

When a drunk driver kills someone, the criminal justice system can punish them with jail time, license suspension, and fines. But for families left behind, criminal penalties don't cover medical bills, lost income, or the emotional and financial fallout that follows.

That's where a wrongful death claim comes in. Under O.C.G.A. § 51-4-2, certain family members have the right to file a civil lawsuit seeking compensation for "the full value of the life of the decedent." This claim focuses not only on what the person earned but also on the experiences and relationships they've been robbed of.

The law allows the following parties to file a wrongful death claim in Georgia, in order of priority:

- The spouse of the deceased
- The children of the deceased (if there is no surviving spouse)
- The parents of the deceased (if there is no spouse or children)
- The estate representative (on behalf of the estate and beneficiaries)

A wrongful death claim is about more than money. It's a legal recognition that your loved one's life had value, meaning, and a future that was stolen.

## Two Legal Actions After a Fatal Drunk Driving Crash

Families often pursue two separate but connected legal actions after a fatal DUI crash:

- **The Wrongful Death Claim:** Filed by surviving family members for the full value of the person's life—both economic and intangible losses.
- **The Estate Claim:** Filed by the estate to recover costs related to the person's death, including medical bills, funeral expenses, and pain and suffering endured before death.

#### **Proving Liability in a Drunk Driving Wrongful Death Case**

While criminal charges against the drunk driver can strengthen your civil case, your right to compensation doesn't depend on a conviction. The civil standard of proof—preponderance of the evidence—is lower than the criminal standard of "beyond a reasonable doubt."

That means your attorney can win a wrongful death case even if the driver avoids conviction. To do that, we gather evidence such as:

- <u>Police and Crash Reports</u>: Including BAC test results, field sobriety observations, and officer notes.
- Toxicology Records: Blood alcohol concentration or drug testing data from law enforcement.
- Witness Statements: From other drivers, passengers, or bystanders.
- **Surveillance or Dashcam Footage:** Capturing erratic driving or the moments before impact.
- **Expert Testimony:** Accident reconstructionists and toxicologists explaining how impairment caused the crash.

We also look beyond the individual driver. In some cases, <u>bars, restaurants, or convenience</u> stores that over-served alcohol may share responsibility under Georgia's dram shop laws.

## **Understanding Georgia's Dram Shop Law**

Under O.C.G.A. § 51-1-40, a bar, restaurant, or alcohol vendor can be held liable if they:

- Knowingly serve alcohol to someone who is visibly intoxicated, and
- Know that person will soon be driving.

Dram shop cases require meticulous investigation. Our attorneys obtain receipts, surveillance footage, and witness statements to determine whether the driver was overserved. When evidence supports it, we pursue claims against both the intoxicated driver and the establishment that enabled their behavior.

These cases send a strong message: if you profit from serving alcohol, you share responsibility when that service leads to tragedy.

#### Calculating Damages in a Drunk Driving Wrongful Death Case
